**Sub:** Patta Lands - Removal of Red Sanders Trees form Private lands –  
Clarifications issued on Circular No. 1-C/2003 – Movement of RS wood to  
other states – permission of PCCF is compulsory, whether the source is  
from private or Government land – Clarification – issued – Reg.

Detailed guidelines were issued in the circular 3<sup>rd</sup> to 5<sup>th</sup> cited for the procedure to  
be adopted for removal of Red sanders Trees from the Patta Lands of the private farmers  
and its transport within and outside the states.

In the circular 5<sup>th</sup> cited it has been instructed that for the movement of Red  
Sanders Wood to outside the state of Andhra Pradesh permission of Prl. Chief  
Conservator of Forests has to be obtained. It is observed that some of the Divisional  
Forests Officers are issuing permits for transport of Red Sanders Wood obtained from  
Government sales depot to other states without taking permission of Prl. Chef  
Conservator of Forests, presuming that the instructions contained in the circular are only  
applicable to private patta material.

It is now clarified that permission of Prl. Chief Conservator of Forests has to be  
obtained for issue of transit permits for movement of Red Sanders Wood, procured from  
the state of Andhra Pradesh to other states, whether the source of origin of the wood is  
Government or Private.

The receipt of the circular instructions should be acknowledged by return of post.
